e. Scholarship and Awards – Mike Zody

We had one student that was the recipient of a scholarship in last year's process, that did not have enough credits to be considered a full time student this fall. After some communication with that candidate, a decision

was made to allow her to be in receipt of the scholarship award for the current semester citing her need to be full time in the spring.

Kelly's pulled info on the current student body and it appears we have around 3,500 eligible students for our scholarships in the coming process.

Personalized emails and letters were to each of those eligible students (and their parents/guardians) for the upcoming scholarship application period on 10/16.

There are roughly 400 students that are eligible for more than 1 of our scholarships. Those students will get one detailed letter outlining what they've qualified for

Kelly has moved our process online using MSFT forms. This should make things easier all the way around for students applying

We are targeting the beginning of December for us to receive our packets of info to peruse and score. This is earlier than normal given the changes to the semester driven by COVID.

The total participant count is 670, but we are seeing a lot of people attending more than one event.

As a general comparison, in the same time period last year, in the same time period last we had 1,659 attendees across 19 events – the most substantial being Homecoming events and the Steelers Tailgate.

325 participants in Homecoming events – the largest majority were in the Race to 2020, which was an interactive event with alumni, students and faculty/staff. Over 6,000 miles were logged during the 10-day race period.
